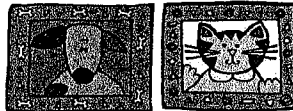

AMENDMENT TO RULES AND REGULATIONS

AMENDMENT TO SECTION XIV – TRAINING CLASS FEES

Page 5 – Lines 1-31

1. **\$30.00 each training course**, except that the Training Director and assistants appointed by the Training Director (i.e., Assistant Training Director, Librarian, Registrars, Properties Chairman, Instructors, Web Master and Newsletter Editor) actively participating in the school training program and Club Officers shall not pay a fee for training their dogs.
2. Instructors teaching a class and not training a dog during a training course shall be entitled to train an equivalent time during the subsequent year at no cost.
3. Any club member who trains more than one dog will be charged the full fee for the 1st dog and a decreased fee of (\$15.00) per training course for each additional dog.

Members not enrolled in a regular class pay **\$5.00** for each hour of training time and, if possible use of the ring, but not to go above regular enrollees. Club members currently enrolled in classes may drop into another class with the Training Director's and Instructor's permission. This excludes ring time.

B. NON-MEMBERS AND AUXILIARY MEMBERS

1. **\$50.00** each dog, each regular training course.
2. The Training Director, with approval of the Board, will set the training fee for special courses.
3. **\$10.00** each hour of training time for a non-member who prefers to train "by the night" when approved by the Training Director.

In the event only one class is offered in any particular training level and a trainee has more than one dog qualified to train in this level, the trainee may train both dogs for a single training fee.

New fees are effective in 2008.

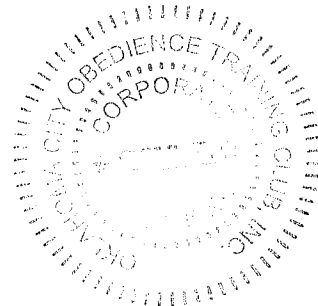
